

'Pay It Forward - Three months fee free travel' terms and conditions

Please read these terms, our [Privacy Policy](#) and any other terms referenced in this document carefully.

First of all thank you for choosing Meon Valley Travel and referring our services. In this document we will seek to clarify the 'Pay It Forward' Campaign. Meon Valley Travel is a Travel Management Company (TMC) and the promoter of this campaign. Meon Valley Travel Ltd registered company number is: 4350445 and the registered office is Harwood House, 43 Harwood Road, London SW6 4QP.

The following terms and conditions apply to the three month fee free travel of the Meon Valley Travel Booking service.

Eligibility Criteria for fee free travel

The referral of a new business travel client from an existing Meon Valley Travel client will be seen as 'eligible' if they meet the following criteria:
